**CONDUCT OF VARIOUS ANNUAL EXAMINATIONS OF 2009**

It is notified for information of all eligible candidates who wish to appear at the B.A. / B.Sc. / B. Com. / B. S. W / B. Sc. (Home Economics) Part-I & Part-II *Regular (Fresh & Failure)*, B. A. (Pass) Part-I *External (Failure Only)*, B. A. (Pass) Part-II *External (Fresh & Failure)*, Annual Examinations of 2009; they may fill-in their Examination Forms obtainable from offices of the Principals of concerned affiliated Colleges with effect from **05-10-2009** as under:

- 1) Without late Fee with effect from **05-10-2009 to 03-11-2009.**
- 2) With late fee of Rs.200/- with effect from **04-11-2009 to 10-11-2009.**
- 3) With late fee of Rs.500/- with effect from **11-11-2009 to 17-11-2009.**
- 4) With late fee of Rs.1000/- with effect from **18-11-2009 to 24-11-2009.**
- 5) With late fee of Rs.2000/- with effect from **25-11-2009.**

**N. B.** No one candidate will be allowed to fill-in his / her Examination Form for appearing as fresh External Candidate of B. A. (Pass) Part-I, Annual Examinations 2009.

**Notes**

1. The following candidates are not eligible to appear in the Annual Examinations 2009:
  - (a) The candidates, who in first instance appeared in Annual Examinations 2004 or prior, as their terms for five years have been lapsed in 2008 or prior (**as case may be**).
  - (b) The candidate, who has passed his / her Intermediate Examination in 2009.
  - (c) The candidate, who failed to clear 50% papers, he / she is not eligible to appear in his / her next higher class examination at the Annual Examinations of 2009.
2. If cases as defined above in “a”, “b” and “c” are detected later on, such Examination Forms will be rejected and fees deposited by such candidates will not be refunded. If said candidates also appears in the Examination, they will do so on their own risk and cost, but their result will stand automatically cancelled.
3. The Examination Form prescribed for one Class cannot be used for other Class.
4. The Candidates must mention their Compulsory / Optional Subjects in Examination Form clearly. However, if candidates fail to appear in the subject (s) mention in the Examination Form & appear in other subject (s) on his own. Such result will not be considered for announcement.

**INSTRUCTIONS / GUIDELINES FOR CANDIDATES**

1. The Examination Form and Bank Challan Form must be filled-in by the candidate himself / herself **SHOWING HIS / HER NAME, FATHER'S NAME AND SURNAME IN THE PRESCRIBED BOXES, ACCORDING TO HIS / HER MATRICULATION EXAMINATION'S MARKS CERTIFICATE.**
2. The examination fees shall be deposited by the candidate himself / herself through designated branches of the Habib Bank Limited in the shape of Bank Challan duly signed by the Principal or his / her authorized representative. Overwriting on the Challan Form shall not be accepted. NO DEMAND DRAFT / PAY ORDER SHALL BE ACCEPTED.
3. The Examination Form along with ORIGINAL COPY OF PAID UP BANK CHALLAN and requisite DOCUMENTS will be submitted to the Principal of the concerned College within due date. The Photocopy / Depositor's Copy of the Bank Challan will not be accepted.
4. Subject (s) opted once cannot be changed at any cost.
5. If an external candidate selects a subject / paper, which is not according to combination of subjects, the result of such subject shall stand cancelled automatically.
6. The candidate has to fill-in the prescribed examination form for the concerned class in which he / she desires to appear, failing which his / her form shall not be accepted.
7. Incomplete examination form will be rejected.
